Frequently Asked Questions:

1. Due to the current global situation with COVID-19, will the deadliness to submit proposals and questions be extended?

The deadlines have been extended in response to the current situation with COVID-19, therefore the new dates consist of the following:

Final date to submit questions: **April 24th, 2020 at 17:00 CET** Final date to submit proposals: **April 30th, 2020 at 17:00 CET**

<u>Please note</u> that due to this extension, the selected applicant will have to be ready to provide the additional documentation required by **May 14th**, **2020** at the latest. Applicants will be notified of the selection on **May 8th**, **2020**.

2. Is it necessary for applicants to be located in the Latin America and Caribbean (LAC) Region?

Applicants must have presence in the LAC Region; however, this does not necessarily mean they need to be physically located in LAC. By presence, we mean have experience working in the region as well as contacts that could facilitate the implementation of the project. Applicants can also apply as a consortium, thus, if one of the participants of the consortium has presence in the region, the consortium would be eligible.

3. Is it necessary for the selected projects to be in different countries, or is it possible to select more than one project in one country?

Selected projects/programs may be located within the same country. However, applicants must submit sufficient reasoning to support their decision, taking into account feasibility and expected benefits.

4. Is it possible to obtain additional information on each of the project/programs apart from the one found in the IFAD website?

Only information that is available to the public can be provided at this stage, meaning the information available in IFAD's website. Applicants must identify the projects/programs based on their location, taking into account feasibility, relevance and added value. Nonetheless, once a proposal is selected, IFAD will be assisting with the coordination between the Country Teams of the existing projects and the selected organization/consortium, as well as providing all necessary information for its implementation. Therefore, it is expected that the proposal might be subject to few adjustments after its approval. The final selection of the projects/programs to be supported will be agreed upon between IFAD and the selected proponent.

5. What are the IFAD projects/programs in which the grant can be implemented?

Below please find the list of current IFAD projects/programs that are eligible for selection and the links to obtain more information on each. The list was prepared based on the closing dates to ensure there would be enough time for implementation. However, if you are interested in including another project/program not listed below, you can substantiate the reasoning ensuring that it is possible to implement the project during the respective timeframe.
