#### Statement of Intent

# Partnership on Cooperation of Evaluation Capacity Development Ministry of Finance, China

#### and

## Independent Office of Evaluation, IFAD 2013/2015

- 1. **Background.** During the meetings held between the Ministry of Finance, China (MOF) and the Independent Office of Evaluation of IFAD (IOE) in Beijing, China, on 20-24 May 2013, it was agreed to establish a bilateral partnership between MOF and IOE for evaluation capacity development in China.
- 2. **Objective of the Partnership.** To contribute to China's development of evaluation capacities of agriculture and rural poverty alleviation interventions.
- 3. **Activities, responsibilities and timeframe.** The proposed activities, responsibilities of partners, and timeframe below reflect the discussion and agreement of the bilateral meetings. On the MOF side, some of the activities would be undertaken in collaboration with the Asia-Pacific Finance and Development Centre (AFDC), which is financed by and affiliated with MOF, and based in Shanghai, China.
- 4. The activities will be carried out in the period of 2013 2015. A joint review of the bilateral cooperation would be conducted jointly by MOF and IOE in early 2016, to assess the cooperation results and direct future cooperation strategy.
- 5. **Focal points.** For the evaluation capacity development cooperation, MOF appoints Ms Tingting Mu, International Department, MOF, as MOF focal point; and IOE has appointed Mr Jicheng Zhang as IOE focal point, under the supervision of Mr Ashwani Muthoo, Deputy Director and Acting Director, IOE. IOE will ensure communication with MOF is copied to the office of IFAD Executive Director of China (in Rome).
- 6. This Statement of Intent, including the table on Evaluation Capacity Development cooperation activities that follows, is (to be) signed by the MOF and IOE.
