#### INDONESIA COUNTRY PROGRAMME EVALUATION

#### Concept Note on the National Roundtable Workshop Jakarta, Indonesia 21 March 2013

#### A. CONTEXT

1. With the purpose to promote accountability and learning, the Independent Office of Evaluation of IFAD (IOE) conducted a Country Programme Evaluation (CPE) in Indonesia in 2012/13. As a usual step in the evaluation process, a national roundtable workshop is held at the end of each CPE by IOE. The Indonesia CPE national roundtable workshop will be co-organised by the Government of Indonesia and IOE, in close collaboration with IFAD's Asia and the Pacific Division (APR).

#### B. <u>OBJECTIVES</u>

- 2. The objectives of the Indonesia CPE national roundtable workshop are to: (i) discuss the main issues emerging from the Indonesia CPE; (ii) provide inputs for the preparation of the evaluation's Agreement at Completion Point (ACP); and (iii) provide an opportunity to reflect on key issues for the forthcoming Indonesia Country Strategic Opportunities Programme (COSOP), to be prepared by APR and the Government in the near future.
- 3. The ACP is a short document summarising the main CPE findings and recommendations, which the Government of Indonesia represented by the Ministry of Finance and IFAD (represented by the Programme Management Department) agree to adopt and implement within specific timeframes. IOE's role is to facilitate the preparation and finalisation of the ACP, which will be included in the final Indonesia CPE report.
- 4. The workshop will entail the participation of representatives from the Government of Indonesia, IFAD Management and staff, NGOs and civil society organisations, directors of IFAD-funded projects and programmes, academics and research institutions, private sector and foundations, donors and selected resources persons. A provisional list of participants is contained in section C of this concept note.
- 5. In addition to participating in the workshop, the IFAD delegation from Rome will visit the Rural Empowerment and Agricultural Development (READ) Programme in Central Sulawesi province, to gain an appreciation of IFAD's and the Government's efforts in reducing rural poverty in Indonesia. This will offer the IFAD delegation an opportunity to directly hold discussions with beneficiaries and their groups, project staff, district-level government authorities and others, as well as see project activities on the ground.

#### C. INDONESIA CPE NATIONAL ROUNDTABLE WORKSHOP

- 6. **Place and timing.** The one-day workshop will take place in Jakarta on Thursday, 21 March 2013. The event will be held at the Mandarin Oriental Hotel in Jakarta. The provisional workshop agenda can be found in appendix 1 of this concept note.
- 7. **Workshop invitations and documentation.** Invitations will be sent to all participants by the Ministry of Finance, in the joint name of the Government of Indonesia and IFAD. The final list of participants will be jointly developed by the Government and IFAD. The final Indonesia CPE report will be shared in advance with all participants as the main background document for the workshop. A PowerPoint presentation will be delivered during the workshop on the key findings from the Indonesia CPE.
- 8. **Key themes for the workshop.** The workshop will focus on the following three key themes emerging from the Indonesia CPE:

Theme 1: What are the implications and priorities for the forthcoming IFAD country strategy in Indonesia? (Moderator: Direktorat Pendanaan LN Multilateral, Bappenas)

Theme 2: What are the key challenges facing the agricultural sector in Indonesia and smallholders in particular? How can IFAD better support agricultural development efforts in Indonesia? (Moderator: Director of International Cooperation, Ministry of Agriculture)

Theme 3: What are the constraints and opportunities for promoting public-private partnerships in agriculture? What role can an agency such as IFAD play in facilitating increased private investment in smallholder agriculture? (Moderator: IFAD)

#### D. Communication and Media Coverage

- 10. In order to highlight some of the strategic issues raised by the CPE and discussed during the workshop, appropriate communication and media coverage will be organised. This will include the following activities:
  - IFAD will prepare the profile and insight papers containing information on key issues emerging from the evaluation.
  - Issue of a press release by IFAD before the workshop.
  - Post the press release and workshop information on the IFAD corporate website, IFAD regional website (IFADAsia).
  - Invitation by the Government of Indonesia to daily newspapers to the workshop to ensure media coverage for the event.
- 11. **Workshop process.** The workshop's provisional agenda (Appendix 1) has been developed in such a way to allow for ample opportunity to exchange views and perspectives among participants and panel members throughout the event.
- 12. The workshop will be chaired by Professor Bambang Brodjonegoro, Head of Fiscal Policy Office, Ministry of Finance of Indonesia, who will start with a welcome remark. Thereafter, Mr Ashwani Muthoo, Acting Director IOE and Mr Kevin Cleaver, IFAD Associate Vice President will make introductory statements. This will be followed by a brief presentation from beneficiaries from each of the on-going IFAD

financed projects in Indonesia. The Honourable Minister of Finance of Indonesia will then make the inaugural address.

- 13. After the coffee break Mr Jayasankar Shivakumar, CPE Consultants' Team Leader will make a PowerPoint presentation highlighting the main findings and recommendations from the Indonesia CPE which will be followed by a question and answer session. The morning session will conclude with an introduction to the workshop working groups. The participants will be divided into three working groups. Each group will consider only one of the three workshop themes (see paragraph 8). The facilitator for each working group will be identified prior to the workshop and the groups will nominate a rapporteur.
- 14. After lunch, the working groups will convene, and start their discussions. Thereafter, the plenary will re-convene to hear the feedback from each of the three working groups. This will be followed by an open plenary discussion, to be facilitated by the workshop chairperson.
- 15. Following the plenary session, Ms Hoonae Kim, Director IFAD-APR and Mr Ronald Hartman, IFAD, Country Programme Manager for Indonesia will share their reflections on the future directions and timelines for preparing the new Indonesia country strategy.
- 16. The workshop's salient conclusions will be set forth in a closing statement to be delivered by a senior Government official, covering the key points arising from both the plenary and working group discussions.

#### E. FIELD VISIT

17. The IFAD delegation from Rome will travel from Jakarta to the Central Sulawesi (to visit the Rural Empowerment and Agricultural Development (READ) Programme. The field visit will take place on 17-19 March 2013, prior to the national roundtable workshop in Jakarta. A detailed programme for field visit will be developed in collaboration with APR and project authorities (see appendix 2).
