Rationale and Objective

To promote ownership and use of its evaluations, IOE organizes dissemination events around its major evaluation products. The dissemination event for the above Thematic Evaluation will address the request by the Executive Board (EB) to elaborate on the key evaluation findings and recommendations.

The key audience are: EB members, IFAD Senior and Middle management involved in designing and implementing Climate Response, and the Regional Climate and Technical Specialists of ECG, and PMI.

Approach

The event will be held remotely and content managed by IOE. It is envisaged to have two components, following the brief introduction.

<u>Introduction</u>: The Director of IOE will introduce the purpose and structure of the session as well as the panel. This will be followed by a brief summary of the developments in providing CCA responses since the evaluation was completed by the AVPs of SKD and PMD. (15 minutes)

<u>Session 1: Presentation of the Evaluation by IOE</u>: The key findings and recommendations will be presented by the Team Leader of the evaluation team. The brief 15-minute presentation will be followed by a Q&A for 30 minutes (Total 45 minutes).

<u>Session 2: A Panel Discussion in the format of "Firing Line"</u> – Three Questions will be posed by a 3-member IOE team; a 4-member IFAD team will provide response.



The questions will be from the following three themes:

- 1. Conceptualizing climate resilience in projects
- 2. Ensuring environmental sustainability of climate solutions (Agriculture eco system nexus) and implications for SECAP and IFAD Climate Strategy and Action Plan (2019-2025)
- 3. Promoting Scaling up and KM related to CCA response

The four IFAD Panelists will represent the successful case studies identified by the Evaluation. The panel comprises of IFAD managers, as well as technical specialists involved with successful climate projects. Each Question will involve a 10-minute exchange [between IOE Team and IFAD Panelists] and during the last 30 minutes, the floor will be open to Q&A from all participants. (Total Time 60 minutes)

- Amath Pathe Regional Climate and Environment Specialist, West and Central Africa region, and Project Technical Lead for a number of successful CCA interventions in Niger and West Africa region.
- Oliver Page Regional Climate and Environment Specialist, LAC region, Project Technical Lead for NICADAPTA, the successful CCA response in that was scaled up in Nicaragua.
